## 1. Salmon Tours by Donation

Partnering with the Sydenham Sportsmen's Association as a fundraising event, these two organizations are offering "Salmon Run Tours, by donation" during the first two weekends of October. A Brochure was created providing trail and the life cycle information of the salmon. Advertising space was offered to: Harrison Park Inn, Owen Sound Marine and Rail Museum, Owen Sound DIA, Artists Co-op, Tom Thomson Art Gallery and Grey Roots – providing \$600 to offset printing costs.

With the first weekend results tallied – 244 visitors toured the Spawning channels, raising \$482.00 which will be split with the Sydenham Sportsmen's Association. The event was damped somewhat with the cool, windy, wet weather but the spirt of the event was warm. Last weekend, we also partnered with the City of Owen Sound in the promotion of the Great Salmon Tour Run Event in hosting a Salmon Tasting that was coordinated by Paulette Pierol of Owen Sound Tourism. Three local chefs from Cobble Beach, Georgian College and Rocky Raccoon prepared Salmon to taste in our Arboretum Pavillion. The Salmon tasting was well received by all in attendance.

This upcoming weekend the weather will be fabulous for the Spawning Channel Tours! Sydenham Sportsman and Foundation directors will be at the Grey Sauble Administration Centre from 10:00 a.m. to 4:00 p.m. to provide an informative tour by donation.

## 2. Inglis Falls Gatehouse

As you are aware, Inglis Falls is the major tourist attraction in our watershed and what better way to accommodate the tourist's quest for information of the area, is to provide a gatehouse attendant. As a Fundraising Initiative, The Foundation is manning the Inglis Falls Gate House the week of October 6<sup>th</sup> to October 10<sup>th</sup> as

our fall tourists are seeking the spectacular fall colours. The first two days of manning the gatehouse had 183 visitors ranging from around the world for example: Scotland, Kingston, British Columbia, Southwestern Ontario, Timmons, Minnesota, Netherlands, and Texas, just to name a few. Revenue \$370.00 for two days. Estimated revenue for the foundation will be \$1,000.

#### 3. Forest Festival

The Bruce Grey Forest Festival has 32 hands-on, interactive activity centres that are educational and fun for Grade 7 students in Grey and Bruce Counties. Students enjoy themselves using cross-curricular skills to learn about our forest resources and the interconnections with the environment.

The site hosts 300 Grade 7 students and 120 volunteers each day during the three day event. We could not host this event without our sponsors – Trillium Foundation, Bruce Power, Grey County, TD Friends of the Environment, and many others! A special thank you to Hydro One Forestry staff and Apprentices in the set-up, operation, and take down of the Festival.
