

# GREY SAUBLE CONSERVATION AUTHORITY MINUTES - AGM Full Authority Board of Directors Wednesday, January 24th, 2018, at 1:15 p.m.

The Grey Sauble Conservation Authority Board of Directors meeting was held at the Conservation Authority Administration Centre located on Inglis Falls Road.

### 1. <u>Call to Order</u>

Chair Dick Hibma called the meeting to order.

#### 2. Disclosure of Pecuniary Interest

The Directors were reminded to disclose any pecuniary interest that may arise during the course of the meeting. No disclosures of pecuniary interest were expressed at this time. Dick Hibma advised that in the expenses under cheque number 9936 he was reimbursed for use of personal credit card for fuel for a GSC vehicle.

#### 3. <u>Remarks from the Chair</u>

Dick Hibma reflected on his past association with Grey Sauble Conservation which began in December 1994 when he first served on the Board as a Director on

behalf the City of Owen Sound. Dick served as the Chair for all but one year since 1998. As of this meeting, Dick will step back and is not seeking re-election as Chair and will sit on the Board as Past Chair for the remaining year of his appointment. Dick also reflected on his term with Conservation Ontario and accomplishments there. He spoke on how 23 years with Grey Sauble Conservation have been an incredible opportunity and he has been blessed to work with amazing and dedicated people, with thanks to all.

Al Barfoot entered the meeting at 1:45 p.m.

# 4. <u>2017 Accomplishment and 2018 Highlights</u>

Sonya Skinner, CAO, made a presentation on accomplishments made in 2017 and projects for 2018. Items included an asset management plan, Stewardship pilot, Phragmites removal, a new brochure, a flow chart for the public called "Navigating the Process" to make it easier to seek permits, Riverfest, planting of over 100,000 trees, a new GPS base station, Drinking Water Source Protection Plan amendments, Drinking Water Risk Management Plans, improvements at Bognor and Inglis Falls and the first phase of GSC's Strategic Plan update. Several items were completed with support from the GSC Foundation. Two accomplished senior staff also retired, Anne Lennox and Krista McKee.

WHEREAS the Conservation Authorities Act provides that an Authority shall have the power to determine the portion of total benefit afforded to each municipality in establishing the annual levy, the Grey Sauble Conservation Authority resolves as follows, subject to such regulations under the Act as may be approved by the Lieutenant-Governor-in-Council:

- i) That all participating municipalities be designated as benefiting for all projects included in the <u>2018</u> Operating Budget including administration and maintenance and the <u>2018</u> Capital Budget unless otherwise specified in the budget;
- ii) That the Authority's share of the cost of the program and projects included in the <u>2018</u> Budget shall be raised from all participating municipalities as part of the General Levy, unless otherwise specified in the budget;
- iii) That the 2018 General Levy be apportioned to the participating municipalities in the proportion that the modified current value assessment of the whole is under the jurisdiction of the Authority, unless otherwise provided in the levy or a project;
- iv) That the appropriate Authority officials be directed to advise the participating municipalities pursuant to the Conservation Authorities Act and the regulations made thereunder; to levy the said municipalities the amount of General Levy set forth in the <u>2018</u> Operating Budget, to levy the said municipalities the amount of the General Levy set forth in the <u>2018</u> Capital Budget and in the approved projects of the Authority, and any special levy attributable to any project which has been deemed to be of specific benefit to any particular municipality.

Tim Lanthier made a presentation to the Board on enforcing the provisions of the Conservation Authorities Act and any related regulations. Previously Provincial Offences Officers designations were applied to specific positions of which now one is currently vacant and the other position no longer exists.

Al Barfoot asked if there was an expiry date on the designations and there is not. There may be changes again because of the Conservation Authorities Act. Harley Greenfield asked if someone from the Forestry and Water Departments should also have staff appointed. John McGee commented that it is a convenient solution for now but enforcement officers should be attached to the job positions and a review of same should be carried out. Sonya Skinner stated that staff must be properly trained and the Strategic Plan may indicate more staff need to be trained.

Between 100 and 200 people have provided comments that highlight their thoughts on GSC's strengths, weaknesses, opportunities, and threats (SWOT) and how they think we can better conserve, restore, develop, or manage the natural resources in our watershed. There are four focus areas: clarification, protection, adaptation, and expansion.

Ana Vukovic brought to the attention of the Board a letter from the Hepworth Anglers Club, with regards to the Spring Creek which they own and abutting lands across private property. Grey Sauble Conservation and the Hepworth Anglers Club have had a long-standing relationship. The Club will be contacted with the possibility of being a deputation at a future BOD's meeting.
