

## PROPERTY & REGULATION INQUIRY LETTER

The purpose of a property regulation and inquiry request is to assist potential buyers/sellers in determining if a property is affected by Ontario Regulation 41/24: Prohibited Activities, Exemptions and Permits as administered by Grey Sauble Conservation Authority (GSCA). This letter is intended to provide a formal record of communication between GSCA and the landowner/potential landowner and to aid in their decision-making process. This letter is restricted to a desk-top review of the property and is scoped to address the following items:

- Is the property affected by GSCA policies and regulations;
- What general requirements/policies from GSCA's perspective may apply to the property;
- Are there any previous or outstanding compliance issues on the property related to Ontario Regulation 41/24; and
- A copy of a map of the Ontario Regulation 41/24 area, if there is any that exists on the property.

**2026 FEE: \$235.00**

GSCA requires the following information in order to process your request:

- **A letter/email of inquiry** – this can be submitted to our office requesting the inquiry specific to a property. Please include contact information and an email address.
- **Location of Property** – clear identification of the property in question. Including assessment roll number, survey where available and/or geographic extent outlined on a map;
- **Payment of Fee** – fee is per property (parcel).

**Please Note:** Requests are handled on a first-come, first-served basis. A request is not considered complete until all of the required items have been received by our office. Processing timelines vary based on staff capacity and current work volumes. Given current challenges in staff capacity and volumes of planning and permit applications, staff are not able to offer a comprehensive review of a proposal prior to the purchase of a property.
